## Declaration

## Compliance status

### Partially compliant

This website is partially compliant with the requirements set forth in Appendix A of the UNI CEI EN 301549 standard due to the non-compliance cases listed below.

## Non-accessible content

The following content is not accessible for the following reason:

a. Non-compliance with Law No. 4 of January the 9th, 2004:

- C.9.1.1.1 – Some non-text content presented to users lacks a text alternative serving the same purpose;
- C.9.1.2.2 – Some pre-recorded audio content lacks synchronized subtitles;
- C.9.1.2.3 – Some pre-recorded multimedia lacks an alternative or audio description;
- C.9.1.2.34 – Some multimedia lacks real-time captions;
- C.9.1.3.1 – In some cases, information, structure, or relationships conveyed through presentation cannot be programmatically determined (or are not available via text);
- C.9.1.3.4 – The display and operation of some content depend on screen orientation, e.g., vertical or horizontal, unless essential;
- C.9.1.4.1 – In some cases, color alone is used to identify meaning or distinguish information or functionality;
- C.9.1.4.3 – The visual presentation of text and images of text does not always meet the minimum contrast ratio required, with exceptions (e.g., logos);
- C.9.1.4.4 – Some text, excluding captions and images of text, cannot be resized up to 200% without assistive technology, without content or functionality loss;
- C.9.1.4.5 – In some cases, images of text are used instead of plain text and are neither customizable nor essential to the conveyed information;
- C.9.1.4.10 – Content not requiring two-dimensional layout (e.g., tables, maps) does not reflow when user agent display size changes;
- C.9.1.4.11 – For some essential components, color contrast with adjacent elements does not exceed 3:1;
- C.9.1.4.12 – Adjusting text spacing (line height, paragraph spacing, letter or word spacing) may result in content or information loss;
- C.9.1.4.13 – In some cases, when pointer hover or keyboard focus reveals/hides content, there is no mechanism to dismiss the additional content without moving the

pointer or focus, nor does the content remain visible until dismissed or irrelevant, except in some allowed exceptions;

- C.9.2.1.1 – Some functionalities are not operable through a keyboard interface (or similar input);
- C.9.2.1.2 – Keyboard focus cannot be moved to a page component via keyboard interface, and no method is provided to do so;
- C.9.2.2.2 – Some animations, blinking, scrolling, or auto-updating content exceeding five seconds or running in parallel with other content lack mechanisms to stop or hide them;
- C.9.2.4.1 – No mechanism is available to skip repeated content blocks across multiple pages;
- C.9.2.4.3 – On pages navigated sequentially, some focusable objects are not ordered to maintain meaning or operability;
- C.9.2.4.4 – The purpose of some links cannot be determined from the link text or from the link text together with adjacent content;
- C.9.2.4.6 – Some headings and/or labels do not clearly describe content or functionality;
- C.9.2.4.7 – Some interactive elements lack visible focus indicators;
- C.9.2.5.3 – For some UI components with labels containing text or images of text, the accessible name does not contain the visually presented text;
- C.9.3.2.1 – Some UI components cause context changes when they receive focus;
- C.9.4.1.2 – For some UI components (e.g., form elements, links, script-generated components), name, role, state, properties, and values are incorrect or not set, or users/assistive technologies are not notified of changes;
- C.9.4.1.3 – Some status messages are not presented in a way that assistive technologies can interpret them without moving focus.

## Accessibility statement drafting

The evaluation was carried out by a third party through objective and subjective assessments (see Article 3, Paragraph 1 of Commission Implementing Decision (EU) 2018/1523).
